BASF COMPETITION TERMS AND CONDITIONS

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY ENTERING A COMPETITION AND SUBMITTING YOUR SCRIPT OR SHORT FOR CONSIDERATION, YOU ARE GRANTING RIGHTS IN YOUR SCRIPT OR SUBSEQUENT SHORT TO FILMAKA LLC. AS STATED IN THESE TERMS AND CONDITIONS.

1. <u>Definitions</u>. Capitalized words used herein have the followingmeanings:

a. "Acceptance" means the Company's acceptance of a Script or subsequent Short meeting the requirements of Paragraph2.

b. "Agency" means Leagas Delaney-London Limited.

c. "Company" means Filmaka LLC

d. "Competition" means the BASF "15 Minute Pit Stops"Competition described on Company'swebsite.

e. "Delivery Rules" means the BASF Delivery Rules available on the Company'swebsite.

f. "Member(s)" means an individual who has validly joined the membership of Companyas determined by Company in its sole discretion as per <u>Company's Membership Terms &</u> <u>Conditions</u> available on Company's website.

g. "Option" means the option set forth in Paragraph3a.

h. "Option Period" means the period of time set forth in Paragraph3a.

i. "Rights" has the meaning set forth in Paragraph3.

j. "Script" means a document in PDF format submitted to the Company which consists of written material for a short film of three (3) to five (5) minutes in length, based on the theme described on the Company's website for theCompetition.

k. "Short" means a short film (between three (3) minutes and five (5) minutes inlength) based on the submitted Script chosen by Company.

1. "Terms and Conditions" means these terms and conditions.

2. <u>Submission Requirements</u>. In order to validly submit a Script or subsequent Short for the Competition, it must meet all of the following conditions for Acceptance, as determined by the Company in its sole and absolutediscretion:

a. You must be of legal age to enter into legally binding agreements in the jurisdiction in which youlive.

b. You must be aMember.

c. A Script must be based on the theme designated by the Company for the Competition on the Company'swebsite.

d. A Script and any subsequent Short based thereon must not contain any content that would be rated more restrictively than"R".

e. A Short must be between three (3) and five (5) minutes inlength.

f. You must upload your Script or subsequent Short, if any, in a timelymanner.

g. You must submit your correct telephone number and emailaddress.

h. You must accept these Terms andConditions.

i. You must accept the Terms of Use and Privacy Policy found on the Company's website.

j. You must enter a valid electronic signature.

k. You must meet the Delivery Rules which are deemed to be a part of these Termsand Conditions and are incorporated herein byreference.

1. You must provide appropriate banking documentation, as determined by the Company inits solediscretion.

3. Grant ofRights.

By uploading a Script for the Competition, you hereby grant to Company the following rights (the "Rights"):

a. a three-month option (the "Option") commencing with the date which is the final date for submission of Scripts for the Competition (the "Option Period") to acquire the Exclusive Rights, including without limitation all rights protected under Section 106 of the Copyright Act, to such Script and any Short based thereon. If your Script is selected as one of three (3)Finalists, as hereinafter defined, during the Option Period, the Option shall be deemed to have been timely exercised by the Company and you will have granted to the Company complete ownership of, and the Exclusive Rights in, your Script and any subsequent Short based thereon in all media, throughout the world, inperpetuity.

b. the right in perpetuity to use your name, address, voice, statements, biography, photograph, image and other likenesses without any further consideration, in any medium, including, without

limitation, in still photos, film, video, television, radio and the internet, and in any publicity carried out by Company or any of its related entities, insurers, promotions companies and service providers, unless prohibited by law.

c. during the Option Period and in perpetuity if the Option is deemed exercised, the right to change, add to, take from, translate, reformat or reprocess the Script or subsequent Short in any manner Company may in its sole discretion determine. To the fullest extent allowable under any applicable law, you hereby irrevocably waive or assign to Company your so-called "moral rights" or "droit moral." If under any applicable law the above waiver or assignment of "moral rights" or "droit moral" is not effective, you agree to exercise such rights reasonably and in a way that will not have a material adverse effect upon any other individual or upon Company's exploitation of the Script orShort.

d. You must agree to the following, which is at BASF's sole discretion:

-To allow BASF and Agency the right to use name, visual performance, likeness, and voice in all Deliverables, and on all accompanying PR materials, social posts, editorial, industry awards, exhibitions and trade shows as required.

-Should BASF require, to be available for and participate in up to two (2) x PR/press opportunities, that BASF would pay for, which may include a "question and answer" session on the finalist's experience, and which may be recorded and streamed live on BASF'S social media channels.

-To share a mutually agreed upon social post relating to or including final Deliverables on finalist's social media account(s).

-Agree not to name BASF or make reference to the campaign on any social platform without prior consent from the Company or BASF.

-BASF has full ownership of any and all materials created in connection to the Shorts.

4. <u>Competition</u>. From those Scripts which are validly submitted and accepted by Company, BASF will select three (3) Scripts (the "Finalists"), and, subject to Paragraph 6.b. of these Terms and Conditions, Company will pay the sum of Fifteen Thousand Dollars (\$15,000.00) to the Member (s) submitting each such Script under the Company's direction and approved budget, such sum to be used by the Member(s) to produce a Short based upon such Script. All decisions of BASF and/or Company will befinal. With respect to the production funds awarded to the three (3) Finalists, the final payment of 25% of the production budget (\$3750.00) will be withheld until all delivery items as per the Delivery Rules on the Company website have been sent in and approved by Company.

5. <u>Consequence of Invalid Submission</u>. If a submission of a Script or subsequent Short is invalid for any reason, Company will have the right, in its sole discretion, to implement one or more of any of the following sanctions: (a) to reject the Script or subsequent Short or to rescind Company's Acceptance of the Script or subsequent Short; (b) to refrain from making or to rescind the payment of any money; and(c) to terminate the Member's status as aMember.

6. CompetitionRestrictions.

a. You must be of legal ageto enter into legally binding agreements in the jurisdiction in which youlive.

b. Company reserves the right to cancel the Competition in the event that Company determines, in its sole discretion, that there are an insufficient number of entries submitted for the Competition.

c. With respect to a Finalist, the final payment of 25% of the production budget(\$3750) will not be awarded without submission of a technically acceptable master in HD and appropriate tax and banking documentation, both as determined by Company in its solediscretion.

7. <u>Notification</u>. Members will be notified by email and by telephone. In the event that a Member does not respond to such notification within two (2) days, a disqualification and forfeiture mayresult.

8. <u>Finalists</u>. If your Script is selected as a Finalist, you agree to direct and produce a Short based on your Script and to deliver the Short to Company in accordance with Company's direction.

9. <u>Your Representations and Warranties</u>. You represent and warrant that (i) you are of legal age to enter into legally binding agreements in the jurisdiction in which you live; (ii) your Script and any Short based thereon are wholly original with you; (iii) you have the full right and authority to grant the Rights as set forth herein; (iv) Company's exploitation of the Rights will not violate or infringe any rights of any persons,and

(v) you are under no obligation or disability, created by law or otherwise, which would in any manner or to any extent prevent or restrict you from entering into and freely performing your obligations under this agreement.

10. <u>Indemnity</u>. You hereby indemnify and hold Company, including but not limited to its employees, directors and assigns, harmless with respect to any loss, cost, or expense (including attorneys' fees), due to any claim by you or any other parties relating to the Rights or the exploitationthereof.

11. <u>NoDownloadingorCopying</u>. You agree not to download or copy any Scripts or subsequent Shorts,

andyouwillindemnifytheCompanyforanyloss,costorexpense(includingattorneys'fees)if you breach this provision.

12. <u>Notices</u>. All notices shall be in writing and shall be delivered by e-mail to each party's last known emailaddress.

13. <u>Entire Agreement</u>. These Terms and Conditions and the other items referred to herein represent the complete agreement of the parties relating to the subject matterhereof.

14. <u>Amendment</u>. The Company reserves the right to amend these Terms and Conditions at any time by posting notice thereof on itswebsite.

15. <u>Governing Law</u>. These Terms and Conditions are governed by the laws of California (i.e., without regard to its conflict of law principles). The exclusive location for any litigation relating to these Terms and Conditions shall be the courts located in Los Angeles, California and you expressly consent to the jurisdiction of suchcourts.

16. <u>Taxes</u>. By law, the Company is required to withhold 30% of all prize and award money and remit it to the U.S. IRS unless the Member is a U.S. citizen or resident and submits to the Company a signed Form W-9 with the Member's social security number. All prize and award money is fully taxable to U.S. citizens or residents, and any withheld taxes (if no Form W-9 is submitted) will be available as a credit against such tax liability. Foreign persons should check their local tax advisors as to whether the withheld taxes are available as a credit against local taxes.

17. Disclaimer. It is possible that a Script or Short or material based thereon posted to Company's website may be downloaded or copied by third parties without permission, and you waive any claim against Company for such actions. Company is not responsible for telecommunications, network, electronic, technical or computer failures of any kind or for lost, stolen, misdirected, mutilated, damaged, garbled, delayed, misdirected, incorrectly addressed, undeliverable, destroyed, late, incomplete or illegible entries, including: any hardware or software failures of any kind; lost or unavailable network connections; failed, incomplete or garbled computer, telephone or satellite transmissions; incorrect, inaccurate transcription or loss of entry information; typographical or system errors; any viruses transmitted to computers of participants via the internet; problems or technical malfunctions of any telephone network or lines, computer online systems, servers, providers or computer equipment; or technical problems or traffic congestion on the internet or any combination thereof; or for any technical or human errors associated with the Competition. Entries not in compliance with these Terms and Conditions will be disqualified. Company shall have the sole and absolute discretion to determine if an entry is in compliance with these Terms and Conditions. Company is not responsible for typographical or other errors in the offering or administration of this Competition, including but not limited to errors in advertising, the selection and announcement of Finalists, or the distribution of any award. Company shall not be responsible for any injury or damage to a participant's or any other person's computer related to or resulting from participating in the Competitionor downloading any material for the Competition which may limit a participant's ability to participate. Company may disqualify anyone from participating in the Competition or winning a prize, if in its sole discretion it determines that person is attempting to undermine the legitimate operation of the Competition by cheating, hacking, deception, or other unfair practices or intending to annoy, abuse, threaten or harass any other participants or Company's representatives. You appoint Company attorney-in-fact for such purposes (it being acknowledged that such appointment is irrevocable and coupled with an interest) with full power of substitution and delegation if you fail to do so within two (2) days of Company's writtenrequest.

19. <u>Disqualification</u>. THIS COMPETITION IS VOID WHERE PROHIBITED BY LAW. Persons included in either of the following categories are not eligible to participate: (a)persons who are employees or agents of Company or its parent companies, affiliates, subsidiaries, advertising or promotion agencies, and its immediate families (spouse, parents, children and siblings and their respective spouses) and individuals living in the same household of such persons; and (b) persons who are engaged in the development of, production of, distribution of materials, or selection of participants and/or the Finalistsfor thisCompetition.
